THE SOCIETIES REGISTRATION ACT, XXI OF 1860

RULES AND REGULATIONS OF ASSOCIATION

OF

DEFINATION: The Society shall be called as

" **SOCIAL ECONOMIC WELFARE ASSOCIATION (SEWA)** "

LOCATION: The registered office of the Society shall be located at Village-

Gandakul (Kaspa), Po-Ahlyas, Block-Dasarathpur, Dist-Jajpur, Odisha, Pin-755036

ESTABLISHMENT: The Society (Here-in-after called as Association) was established on 5th July 2011.

JURISDICTION: The area of operation or jurisdiction of the Association shall ordinarily be in the district of Jajpur and can be in extended after completing the formalities therein.

DIRECTIVE BODY: Members elected or nominated to the **Governing Body of the Association** by the General Body Shall be called as the **Directive Body**.

MEMBERSHIP: Any person irrespective of caste or creed who has attained the age of 18 years can become a member of the Association after making a written application to the President of the Organization. The number of members shall be decided by the General Body of the Association.

CEASATION OF MEMBERSHIP: The Membership of a member of the Association can be ceased if:

- (i) He/She absents himself/herself from 03 (three) consecutive meetings of the Association.
- (ii) He/She is found working against the interest of Organization.
- (iii) He/She is found unsound of mind.

- (iv) He/She is convicted by Court of Law under Indian Penal Code. And
(v) He/She tenders his/her resignation.

GENERAL BODY : The General Body of the Association shall have the following powers.

- (i) It shall be the apex body of the Organization.
- (ii) It shall conduct Election/Nominations of members to the Governing Body.
- (iii) It shall prepare Annual Action Plan for the Association.
- (iv) It shall sit at least once in a year and can sit more if necessary.

GOVERNING BODY: The Governing Body otherwise known as Executive Body of the Association shall have the following powers.

- (i) The Governing Body shall be the final decision making Body of the Association.
- (ii) It shall be responsible for implementation of Annual Action Plan prepared by the General Body.
- (iii) It can take additional decisions other than the ones taken by the General Body.

NOTICE : A 14 (Fourteen) day Prior Notice and a 7 (Seven) day Prior notice shall be served for convening General Body and Governing Body meeting respectively.

QUORUM: The quorum for both General Body and Governing Body meeting shall be of absolute majority.

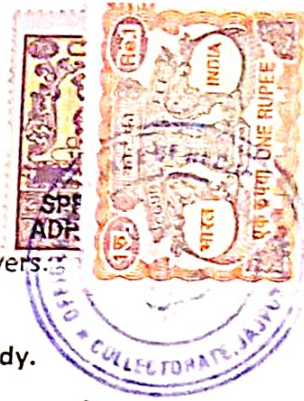
TENURE: The tenure of the Governing Body shall be one year (Financial year) whereas the General Body is a Permanent one.

VOTE: Every member shall have the right to vote including the President.

AMENDMENT: The Constitution (Bye Law and Memorandum) of the Association can be amended by its General Body as and when necessary.

FUNDS: The funds of the Organization shall be raised through:

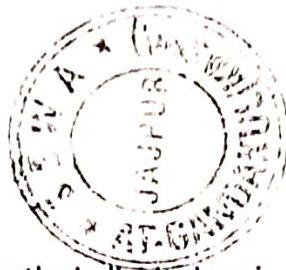

- (E) The Secretary shall be accountable to the General Body for all such omissions and commissions.
- (F) The Secretary shall have power to draw a maximum of Rs 500/- (Rupees five hundred) only without the prior approval of the Governing Body.

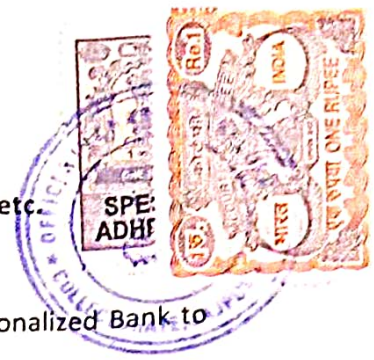

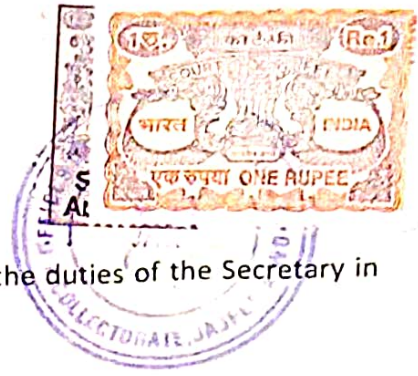

- (F) The Secretary shall have power to draw a maximum of Rs 500/- (Rupees five hundred) only without the prior approval of the Governing Body.

THE SOCIETIES REGISTRATION ACT, XXI OF 1860
RULES AND REGULATIONS OF ASSOCIATION

OF



DEFINATION: The Society shall be called as
" **SOCIAL ECONOMIC WELFARE ASSOCIATION (SEWA)** "

LOCATION: The registered office of the Society shall be located at Village-
Gandakul (Kaspa), Po-Ahiyas, Block-Dasarathpur, Dist-Jajpur, Odisha, Pin-755036.

ESTABLISHMENT: The Society (Here-in-after called as Association) was established on 5th
July 2015.

JURISDICTION: The area of operation or jurisdiction of the Association shall ordinarily be
in the district of Jajpur and can be in extended after completing the
formalities therein.

DIRECTIVE BODY: Members elected or nominated to the Governing Body of the
Association by the General Body Shall be called as the Directive Body.

MEMBERSHIP: Any person irrespective of caste or creed who has attained the age of 18
years can become a member of the Association after making a written
application to the President of the Organization. The number of members
shall be decided by the General Body of the Association.

CEASATION OF MEMBERSHIP: The Membership of a member of the Association can be
ceased if:

- (i) He/She absents himself/herself from 03 (three) consecutive meetings of the
Association.
- (ii) He/She is found working against the interest of Organization.
- (iii) He/She is found unsound of mind.

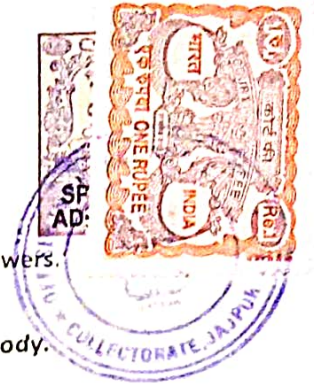

- (iv) He/She is convicted by Court of Law under Indian Penal Code. And
- (v) He/She tenders his/her resignation.



GENERAL BODY : The General Body of the Association shall have the following powers.

- (i) It shall be the apex body of the Organization.
- (ii) It shall conduct Election/Nominations of members to the Governing Body.
- (iii) It shall prepare Annual Action Plan for the Association.
- (iv) It shall sit at least once in a year and can sit more if necessary.

GOVERNING BODY: The Governing Body otherwise known as Executive Body of the Association shall have the following powers.

- (i) The Governing Body shall be the final decision making Body of the Association.
- (ii) It shall be responsible for implementation of Annual Action Plan prepared by the General Body.
- (iii) It can take additional decisions other than the ones taken by the General Body.

NOTICE : A 14 (Fourteen) day Prior Notice and a 7 (Seven) day Prior notice shall be served for convening General Body and Governing Body meeting respectively.

QUORUM: The quorum for both General Body and Governing Body meeting shall be of absolute majority.

TENURE: The tenure of the Governing Body shall be one year (Financial year) whereas the General Body is a Permanent one.

VOTE: Every member shall have the right to vote including the President.

AMENDMENT: The Constitution (Bye Law and Memorandum) of the Association can be amended by its General Body as and when necessary.

FUNDS: The funds of the Organization shall be raised through:

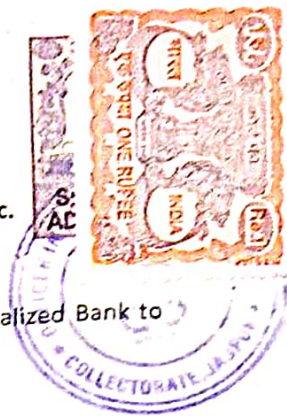

ACCOUNTS: The funds of the Organization shall be deposited with any nationalized Bank to be jointly operated by the President & Secretary of the Association.

AUDITS: The Accounts of the Association shall remain open for audit by any qualified Accountant or any Govt. Accountant.

DUTIES OF OFFICE BEARERS

- PRESIDENT:**
- (i) The President shall preside over all the meetings of the Association.
 - (ii) The President shall countersign/certify the copies of Proceedings of the Association.

VICE PRESIDENT: The Vice President shall perform all the duties of the President in his (President's) absence.

SECRETARY:

- (A) The Secretary shall act as the Chief Functionary of the Association.
- (B) The Secretary shall be custodian of all records/assets of the Organization.
- (C) The Secretary shall countersign important records including Cash Book, Cash Vouchers of the Organization.
- (D) The Secretary shall convene all the meetings of the Organization.
- (E) The Secretary shall be accountable to the General Body for all such omissions and commissions.
- (F) The Secretary shall have power to draw a maximum of Rs 500/- (Rupees five hundred) only without the prior approval of the Governing Body.

LEGAL ACTION: The Secretary may sue or be sued for any loss or damage of any movable or immovable properties of the Organization.

DISSOLUTION: Upon dissolution of the Society its shall be handed over to a similar type of Registered society or Government after clearing up all its debts or liabilities provided that no Society shall be dissolved unless 3/4th of its members shall have expressed a wish for such a dissolution in a General Body meeting by presenting themselves or giving their consent in writing. Provided that no society registered under this Act shall be dissolved without the consent of the government where the govt. is a member contributor or otherwise interested.
